

ADVERTISEMENT FOR BIDS

A project funded by CDBG funds

Sealed proposals will be received by the Preble County Board of Commissioners, 101 East Main Street, Eaton, Ohio 45320 until **11:00 a.m. (local time) on Wednesday, June 22, 2011** for furnishing all labor, materials, and equipment necessary to complete the project known as **Village of Eldorado – Wastewater Treatment Plant Alterations – Phase I – Contract B**. The bids will then be publicly opened and read aloud. The work for which proposals are invited includes the refurbishing and repainting of several existing wastewater tanks located at the wastewater treatment plant.

Contract Documents including specifications and the plans may be examined or obtained at the office of the Preble County Board of Commissioners, 101 East Main Street, Eaton, Ohio 45320 or at Mote & Associates, Inc., 214 West Fourth Street, Greenville, Ohio 45331. A non-refundable charge for each set of the Plans and Contract Documents will be required in the amount of \$45.00.

A pre-bid meeting is scheduled for Monday, June 13, 2011 at 1:00 p.m. at the Village of Eldorado Wastewater Treatment Plant, Eldorado, Ohio.

Project completion date will be 80 calendar days from the date the Notice to Proceed is issued.

Each bidder is required to furnish with its proposal a 100% Bid Guaranty and Contract Bond or a certified check, or a cashier's check upon a solvent bank in the amount of 10% of the bid in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experience on projects of similar size and complexity.

Additionally, attention of bidders is called to all of the requirements contained in the Contract Documents and on the plans, particularly to the Federal Labor Standards Provisions, various insurance requirements, various equal opportunity provisions, and the requirement for a 100% Performance and Payment Bond.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

The Preble County Board of Commissioners reserve the right to accept or reject any or all bids, to waive any informalities in the bidding and to enter into a contract with the bidder who in their consideration offered the lowest and best bid.
