Sealed bids will be received at the Village of Arcanum, 104 West South Street, Arcanum, Ohio 45304 until 11:00 A.M. (local time), on Monday, June 21, 2010, for furnishing all labor, materials, and equipment necessary to complete the project known as **Sanitary Sewer Separation Phase III – Contract E – Albright Street Reconstruction**. The bids will then be publicly opened and read aloud. The work for which proposals are invited is for the reconstruction of 885 L.F. of Albright Street. The reconstruction shall include new waterline, storm sewer, aggregate base intermediate asphalt course, and surface asphalt course.

A **pre-bid meeting** will be held on Monday, June 14, 2010 at 10:30 A.M. at the Village of Arcanum, 104 West South Street, Arcanum, Ohio 45304.

Contract Documents including specifications and the plans may be examined at the office of the Village of Arcanum, 104 West South Street, Arcanum, Ohio 45304 or obtained at the office of Mote & Associates, Inc., 214 West Fourth Street, Greenville, Ohio 45331. A non-refundable charge for each set of the Plans and Contract Documents will be required in the amount of **\$65.00**. An additional non-refundable handling charge of **\$15.00** per set is required, if documents are to be shipped. **Proposals will only be accepted from bidders who have obtained Contract Documents (including plans and specifications) from Mote & Associates, Inc. and have been registered as a planholder.**

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on the projects of similar size and complexity, and a complete listing of all subcontractors to be used. The Owner intends and requires that all construction be completed by 90 days after Notice to Proceed is issued. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

Bidders must comply with the prevailing wage rates on Public Improvements in Darke County and the Village of Arcanum as determined by the Ohio Bureau of Employment Services, Wage and Hour Division, 614-644-2239.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of this project. Additionally, Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order 1972, and the Governor's Executive Order 84-9 shall be required.

The Village of Arcanum reserves the right to accept or reject any or all proposals, to waive any informalities in the bidding, and to enter into a contract with the bidder whom in their consideration offered the lowest and best proposal.
